Brand Bill Of Sale/Ownership Amendment

If the ownership of a brand changes, either by the addition or removal of named owners, or the complete transfer of ownership to a new person or entity, as long as the current owner is not deceased, a Bill of Sale is required. Before any changes can be made, the brand must be current (i.e. not in expired status). To complete this application, please read and follow the instructions below:

Complete Application – Includes all of the following:

- ☐ Name of *current owner(s)* as it appears on the brand;
- ☐ Brand Number;
- ☐ The names of all new applicants specified by “OR” or “AND”. **If the original owner is retaining partial interest in the brand, original owner must sign as both the Seller and the Buyer and be listed as an applicant.**
- ☐ DBA or Name under which livestock will be shipped or sold, ***only if different from applicants;***
- ☐ Mailing Address;
- ☐ Telephone Number(s);
- ☐ Email address (if applicable);
- ☐ Range Location and County;
- ☐ **Acknowledged Signatures of all specified parties** witnessed by either a Notary Public, Justice of the Peace, a Judge of a court of record, a Clerk or deputy Clerk of a Court having a seal, a Recorder of Deeds, a County Recorder, or Livestock Officer. If all parties involved in the application are unable to appear for acknowledgement at the same time, a separate acknowledgement may be attached for additional signatures.
- ☐ If ownership is being distributed to a business entity, you must provide a copy of the business organizational papers (i.e. Articles of Incorporation or Articles of Organization).
- ☐ If ownership is a Trust, you must provide a copy of the Trust paperwork which details who has authority to sign for the Trust.

Application Fee: The fee for a bill of sale is \$25.00.

Please Note: Bill of Sale does not change the expiration date of the brand.
