Instructions to Complete Bill Of Sale/Ownership Amendment

1. If more than one (1) name is used as owner, "OR" or "AND" must be specified between names.
2. If ownership is being transferred to a business entity, a copy of the business organizational papers must be provided (i.e.: Articles of Incorporation, Partnership Agreement, Articles of Organization, etc.).
3. If the original owner is retaining partial interest in the brand, original owner must sign as both the Seller and Buyer.
4. A \$25.00 fee must be submitted for the processing of each Bill of Sale/Ownership Amendment and the issuance of a new Brand Certificate.
5. All specified owners must sign the Bill of Sale/Ownership Amendment. All signatures must be acknowledged by a Notary Public, a Justice of the Peace, a Judge of a court of record, a Clerk or deputy Clerk of a Court having a seal, a Recorder of Deeds, a County Recorder, or Livestock Officer. Those not properly acknowledged will be returned. If all parties involved in the application are unable to appear for acknowledgement at the same time, a separate acknowledgement may be attached for additional signatures.
