1. PURPOSE

This order adopts and provides for the enforcement of the restrictions on the intrastate movement of certain articles that are equivalent to the movement restrictions imposed by 7 C.F.R. Subpart 301.89 concerning Karnal Bunt. See 7 C.F.R. § 301.89-3(b)(1)(i) (2015). This order supersedes DAO 15-01 issued on November 5, 2015

2. AUTHORITY

A.R.S. § 3-201.01. Associate director; powers and duties
A.R.S. § 3-202. Infested or infected plants as public nuisances

3. ORDER

All intrastate movement of regulated articles listed in 7 C.F.R. § 301.89-2 from regulated areas shall be restricted as set forth in 7 C.F.R. §§ 301.89-4 through 301.89-12, except 301.89-8 and 301.89-11.

Regulated area:

La Paz County. The Department may cancel any certificate, limited permit, or compliance agreement in accordance with 7 C.F.R. § 301.89-8, but a person's right to appeal a cancellation and any resulting hearing shall be as set forth in A.R.S. § 41-1092 *et seq.*

The definitions in 7 C.F.R. § 310.89-1 apply to this order except that "Inspector" means an Arizona Department of Agriculture employee authorized to enforce the provisions of this order and all references to APHIS throughout the incorporated regulations are changed to the Arizona Department of Agriculture.
