Each completed application must include a \$10.00 registration fee - **DO NOT SEND CASH!** Each application for a NEW registration must also include three color photographs showing views of the front and both sides of the equine including its legs. Photographs may be submitted in "jpg" format via e-mail to: **licensing@azda.gov**. Out-of-state equine \* registration applications must include a copy of the out-of-state health certificate with record of a negative equine infectious anemia test (Coggins test), and a copy of the out-of-state brand inspection, or Bill of Sale, or an association registration. Buyers of in-state equine must include the seller's original Equine Ownership Certificate or other document proving Arizona ownership. If Arizona ownership cannot be determined, use out-of-state requirements. Replacement/duplicate card requires a \$10.00 fee. Each completed new or transfer application must include a \$10.00 registration fee.(A.R.S. §§ 3-1344 and 3-1345).

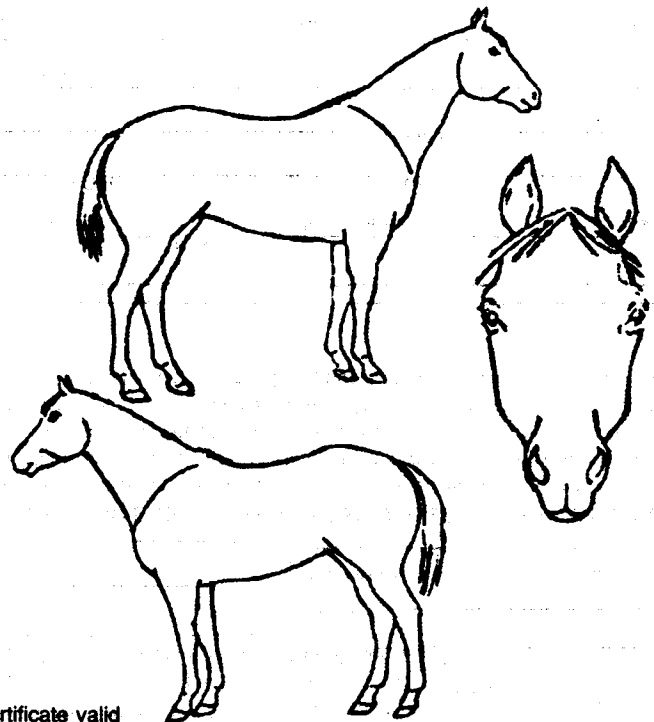
