**Course Description.** Through this workshop, attendees will become qualified to provide Worker Protection Standard (WPS) pesticide safety training to agricultural workers and pesticide handlers in Arizona.

This course is ideal for growers, supervisors, labor contractors, health care providers, outreach educators and others who will provide safety information to people who handle pesticides or work in areas where pesticides are used.

**Workshop Format.** Sessions will cover pesticide labels, personal protective equipment, pesticide-related health issues, general pesticide safety, and WPS training requirements. Participants will receive EPA-approved materials and other useful training resources.

A variety of hands-on training techniques and group activities will be used during the course to demonstrate ways to extend pesticide safety information to pesticide handlers and agricultural workers in an interactive and effective manner.
