The Arizona Department of Agriculture will offer a refresher course for people who want to renew their current Arizona Trainer Certification.

**The Refresher Course is also open to Pest Control Advisors (PCA) and Arizona Certified Agricultural Pesticide Applicators (PUP/PUC/PUG) who want to provide pesticide safety training to employees of farms, forests, nurseries, greenhouses and golf courses.**

**Workshop Format:** This course will include updated information on pesticide laws and regulations, new resources and training requirements. Attendees will also share their experiences as pesticide safety trainers and will provide short presentations during the workshop. The Arizona Pesticide Safety Trainer Exam will be administered at the end of the course.

**Registration is FREE, however SPACE IS LIMITED TO 30 people.**

**Continuing Education Credit** will be available for Arizona licensed agricultural pesticide applicators (PUPs, PUCs, PUGs) and Pest Control Advisors and will be issued following the trainer's exam.
