Course Description: The Arizona Department of Agriculture will offer a refresher course for people who want to renew their Arizona Trainer Certification. Trainer certificates are valid for 30 days after the expiration date. **Trainers whose certificates expire on any date after September 28, 2015 qualify for this workshop.**

The Refresher Course is also available to current licensed Pest Control Advisors (PCAs) or Agricultural Certified Applicators (PUP, PUC, PUG) wishing to obtain their WPS Trainer Certification.


Workshop Format: This course will include updated information on pesticide laws and regulations, newly available resources, and training requirements. Attendees will also share their experiences as pesticide safety trainers and will provide short presentations during the workshop. The Arizona Pesticide Safety Trainer Exam will be administered at the end of the course.
