### **New Product Registration**

#### **Steps for a Speedy Registration:**

*Identify if the product(s) is an Agricultural Use Pesticide or Non-Agricultural Use Pesticide.* Pursuant to:

Arizona Administrative Code (A.A.C.) R18-6-101 (1) – **“Agricultural Use Pesticide”** is defined as any pesticide intended for use directly on a crop. An agricultural use pesticide does not include animal pesticide ear tags or pesticides intended solely for use within and around a confined structure.

A.A.C. R18-6-101 (2) – **“Crop”** is defined as any plant, animal, plant product, or animal product produced for commercial or research purposes.

*Has the Active Ingredient (AI) been approved by the Arizona Department of Environmental Quality (ADEQ)?*

If yes, please include copy of ADEQ AI Approval Letter with remaining application components.

One product for two years = \$200.00

Two products for one year = \$200.00

Two products for two years = \$400.00

*In addition to the information above, the applicant must provide the following (see application)*

- Name and Address of Applicant
- Name of Company appearing on the label(s)
- EPA Registration Number for each product.
- Brand and Name of Product(s)
- Federal Tax ID No.
- Printed Name, Title, Signature, and Contact Information of the registrant including Phone, Email, and Fax (if available).

**Please be aware all product(s) must have the same expiration date for any one company registering product(s).**
