3. Approval of September 6, 2017 Minutes

Paul moved to accept the September 6, 2017 Minutes as presented, Kara seconded the motion. The FAPAC unanimously approved.

4. Keith Watkins, AZ Commerce Authority, Presentation

Keith Watkins, Senior VP for Economic and Rural Development for the AZ Commerce Authority (ACA) presented. ACA's mission is to help the job base in Arizona expand, with a general focus on industrial businesses (but with a focus on small businesses as well). The ACA helps businesses here expand, helps businesses come here and works to increase awareness.

There are qualifying jobs tax credits for employers creating new quality jobs in Arizona and making a capital investment in this state. Additionally, for manufacturing facilities that are looking to expand or relocate in Arizona, there is a qualified tax credit. It all comes down to the definition of "manufacturing" and the NAICS number (with the Department of Revenue).

Next Phase of Recommendations

Sharma updated the FAPAC on the submission of these recommendations to Director Killian. In a letter to Director Killian, Sharma noted the eight recommendations by the FAPAC, as well as the four themes of the recommendations. The letter was submitted on October 5, 2017. And the PowerPoint that David provided was attached to this letter.

"including, but not limited to" added to this. Further, the letter should be signed by Sine as the Chair of the FAPAC. Further, the letter should note that these are short-term goals and that the FAPAC is working on mid to long-term goals as well (not mentioned in the letter).

Sharma will make the aforementioned changes and send the letter to Sine for review.

Working Group Discussion

Because Director Killian entered the room, Sine decided to jump to agenda item #7. See the below.

Since the subcommittees were dissolved, Sine wanted the FAPAC to discuss creating working groups.

Chris noted that the working groups are temporary in nature, are given an assignment, they complete the assignment, report back to the FAPAC, and then they no longer exist. These working groups should contain less persons than would be needed for the FAPAC to have quorum.

After discussion, the FAPAC decided to create the following four working groups:

1) Farm Bill Working Group, which will focus on identifying specific parts, processes, and barriers that are either helpful or a hindrance to the FAPAC's objectives (Paul, David and Leslie);

- A Resource for this group would be the Farm Team, which is a group of various industry, nonprofit, agency persons focused on examining the five titles of the Farm Bill

2) Unified Approaches to State/County Health Regulations and Guidelines Working Group, which will focus on identifying barriers and inconsistencies to state/county regulations and guidelines (Liz, Nikki);

3) Education Working Group, which will focus on staying informed about and be involved in the following: (a) the workshops that will be put on by the AZDA; (b) the Food Summit planning and (c) other educational items of interest (David, Rocco, Leslie);

4) Transportation/Infrastructure Working Group, which will focus on identifying barriers to dealing with food access issues relating to transportation and infrastructure (Liz, David).

6. <u>Discussion on Existing Cooperatives Meeting</u> (Information, discussion and action)

Per the last FAPAC meeting, it was determined that the existing cooperatives should be consulted prior to the FAPAC recommending a change to existing Arizona law regarding cooperatives. A list has been created for the persons representing existing cooperatives that need to be at a meeting. AZDA will hold this meeting.

The FAPAC members are to get a list of names for the meeting to Sharma by the end of the week.

7. <u>Discussion Regarding Churches Being Involved in Efforts</u> (Information, discussion and action)

Director Killian told the FAPAC that he would like churches to be included in these collaborative efforts to tackle food access issues. He is meeting with the mayor of Mesa (Mayor Giles) in a few weeks to discuss holding a workshop in Mesa to tell the churches about the FAPAC and its mission.

The FAPAC thought this workshop could be replicated in other areas around the state as well.
