**Course Description:** The Arizona Department of Agriculture will offer a refresher course for people who want to renew their Arizona Trainer Certification. Those interested must be currently certified as a trainer or have their trainer certification expired for no more than 30 days prior to the workshop.

The Refresher Course is also available to current licensed Pest Control Advisors (PCAs) or Agricultural Certified Applicators (PUP/PUC) wishing to obtain their WPS Trainer Certification.

**Workshop Format:** This course will include updated information on pesticide laws and regulations, newly available resources, and training requirements. Attendees will also share their experiences as pesticide safety trainers and will provide short presentations during the workshop. The Arizona Pesticide Safety Trainer Exam will be administered at the end of the course.


**Registration** is **FREE**; however **SPACE IS LIMITED to 30 people**. Please register early to reserve a space in the workshop.
